Many thanks for inviting me to experience your beautiful islands and for considering my team to develop this very special, exciting and challenging project.

I appreciate your time during this enlightening visit; I believe I now have a much better idea of your needs and expectations.

As I mentioned, the first step is to document and digitalize the existing conditions of the topography, remaining vegetation and structures on both islands in order to determine the portions to be reutilized and have the basis to develop a conceptual master plan.
