






Well he has already answered to please give us more information on Carnet....how does he go about getting a Carnet? can you help with this?

if you are not planning on using the car in France, you do not need to register the car. If your boss is moving to France, he can only drive for 2 weeks with the license plates. Afterward, he needs to register it. Another option might be issuing a Carnet. If he gets a Carnet, he can stay up to one year with the car in the EU and use his American registration, afterward he needs to ship it back to the US.

I would recommend you to introduce me directly to your boss, so I can explain him this. It is a tricky subject...




