Attached is the quote for the orders shipping to the US. I haven't received the updated spreadsheet from my support team yet for you to review to ensure shipping addresses are correct. Once I have that, I'll forward it over for you to verify the information.

Also, re: Europe. The teams in the UK and France are now telling me they no longer accept US credit cards over the phone. This is apparently a new policy they have put in place. Sorry to misinform you. This is a policy change I was not aware of.

This means that either someone with a credit card from each region would have to pay for the items or I will need to ship these items to you and then you will need to forward them to each individual. Also - we do not have a store in Russia, so that would need to be shipped to you either way.

Please let me know if this will work for you and I'll get those added to your order and have them shipped to your office.
