Just FYI-the 2pm Delta flight would not connect to the 7:20pm Aeroflot flight LEGALLY...we could potentially VOID the 2 Jet Blue flights and issue the 2pm Delta flight and she would have 65 min. to make the Aeroflot flight but it will be ILLEGAL connection (which means the airline will not protect her if she misses the flight and money gone and they won't help her get a new flight)

Delta 2pm flight \$520 biz class

Aeroflot 7:20pm flight \$3055 add collect in Biz Class (we OWN this last seat already)

She can run in to issues at JFK because she would check in with Delta in STT ...at JFK they may make her go through security to check in to the Aeroflot flight. It is a dangerous way to go. (Delta flight arrives Terminal 4... Aeroflot takes out of Terminal 1)

The longer layover is the safest way to go. WE need to ticket ASAP to get the biz class fare at \$4822.86 (this last ticket in the lower class price tag) Ok to purchase the 2pm Delta connecting to the 12:55am Aeroflot in Biz? (Fare not guaranteed until ticketed)
