The process is quite easy, the only difference this time is that you need to get an invitation from a Belarusian travel agency, instead of a private invitation (which I did before), the website has references for the agencies when you click on the link. They only accept money orders or cashier's checks, no cash or personal checks. If you have any questions, please call me.
