Thank you for your email.

I am sure you are aware that this "real estate contract" is highly irregular for Americans.

1. It is not a real estate contract, it is a purchase of an offshore entity, creating&n=sp; many complexities for americans.
2. There was never any discussion about real estate fees on top of the price. We have bought many properties, including through Christies and a commission was always paid by seller.
3. The due diligence on a lichtenstein co. will take months.&nb=p;
4. We would have to be indemnified for all taxes due to moroccan government on transfer and unknown liabilities of the co., especially as you might imagine, this purchase would be very high profile.
5. Is there a title on file? who would guarantee title transfer? If Christies is=willing that might work.
6. We were=hoping for a quick closing. With this structure it is not possible, and money would need to be withheld for years to back up the indemnity. It is=very disappointing. We are told that liabilities would extend approx 7 years= so a payment of 10m day one and 2 million per year for 8 years might work= There clearly is no perfect title transfer under your proposed structure.&=nbsp; Four jurisdictions, real estate and corporate and disclosure rules in each. Can you make a suggestion?
