I expect fewer deliveries no noise and I want the staff to know except for time set aside if nec I prefer little conversation. package room and things will wait to be sorted on weekends unless urgent.

Dinners can no longer have the gang in the kitchen. we all need to understand PEACE AND QUIET.

I will have to make significant changes to many things. The business in the island will be dramatically different, if it survives. finding people to rebuild is very difficult as Florida St Barts and much of the Caribbean will all be looking for the same people and material. <br>
