I'm really interested in knowing your reasoning on this.

Jimmy and Lina seem like a good match for us. But my concern is the lack of management and cooking capabilities and we'll need to work around that area. I hope you saw my interview notes and you're not expecting too much from them.

The other area of concern is our staff; [REDACTED] [REDACTED] definitely have their "sympathy vote" and I think we need to handle this with Kidd gloves so we don't erode their confidence in us. The last thing we want is for them to lose trust and begin to look else where. There are too many jobs out there for the staff you've taken years to train...

Although you certainly don't need me to be in agreement to administer your decisions; I'm in total agreement with you on this and will do everything possible to make it as smooth as possible and least stressful for you and Mr. E.
