The police interviewed= [REDACTED] who had visited Mr. Epstein's home only once, but br=ught no charges after interviewing her, though monitored activity at Mr. Epstein♦=99s home through sporadic surveillance and occasional trash pulls.

There are several reasons that explain this result.<=pan style="mso-spacerun:yes"> [REDACTED] told the Palm Beach Police on more than one occasion that she was instructed by [REDACTED]=the woman who brought her to Mr. Epstein's home, that [REDACTED] had to tell Mr. Epstein she was 18 years old because, if she was not 18, he would not let her into his house. [REDACTED] also informed the Police that she did in fact tell Mr. Epstein that she was 18 years old. She also informed police that Mr. Epstein had no sexual contact with her. Mr= Epstein took a lie detector test, the results of which confirmed that [REDACTED] told him=she was 18, that he believed [REDACTED] when she told him her age, that he never threatened [REDACTED] in any way and that no sexual contact occurred with [REDACTED]. In addition, [REDACTED] who=had previous run-ins with the Police, maintained a "MySpace page at the t=me of the investigation on which she stated that she was 18 years old, posted naked an= provocative photographs, admitted to having sex . that she was not a virgin, to using drugs, and to having beaten someone up, and to having shoplifted and claimed t= earn \$250,000 or more.
