- 1)=cash flow will be flat to down 1mm over the next 2 months
- 2) APO payment of 0.35 (32,000,000) is due in November (note =his amount is incorporated in flat statement in 1) =bove

- 4) =ich J believes that cash flow will decrease even further in 2016 due to =maller APO distributions

  - a) =ending art sale set up to be in 1031 however Joe believes replacement =as not properly identified =/span>-> 6,000,000 sales proceeds with 2.5mm cap gain =/span>-> 2,000,000 unrealized gain in Lone Cascade hedge fund =however i am unaware of funds liquidation procedures
- 6) Rich J says remaining charity pledges for 2015 are 15-17mm =hich includes the 3mm he owes your 3 charities (originally due =-30-2015)
- 7) Open charity issue that would affect =ash flow in 1) is Momo
  - > =eon gave a soft commitment of 25mm over 5 years in 2014
  - =/span>-> 2014 was never funded and they are unsure what Leon will do =n 2015
