Confirming:

If suspension is the course: we will not issue a paycheck on Friday for these 3 employees they will be paid through the normal payroll cycle which would be direct deposit on May 11th for the pay period April 23 to May 6th. Then we will suspend pay for the time of the suspension. No accrued vacation check will be issued.
