Any amount written by an individual over this initial \$5000 up to \$30,800 will go to the Republican National Committee (RNC.) In other words if an individual has not written a check to the Romney campaign, that person may write a check up to \$35,800 the maximum amount an individual may write to a candidate and the National Party in a two year period.
