I'm guessing that the bos= means the new iPad Air 2 (the mini update was minor). The 128GB cellular m=del is \$829+ \$99 for AppleCare+. 4-6 days til shipping.

For the MacBook, we have choices between the 11" =acBook Air, the 13" MacBook Air / 13" Retina MacBook Pro or 15" MacBook Pro= depending on who needs it / for what they're using it.

As a baseline, the 13" MacBook Air with Core i7 CPU, 8GB RAM (th= max) and 512GB storage is \$1,749.00 + \$250 for AppleCare. 1-3 day to ship.=nbsp;

The logistics of the iMac upgrades are a cha=lenge. We have three choices:

1. Buy cardboard shi=ping boxes for Zorro, Paris, + Florida and have them ship the machines to N= for me to migrate the data.

I will go down =o the island and handle the 5 machines there (air flight cost vs shipping c=st of 5 machines). If desired, we can send 5 boxes down & I can pack th=m up to be returned to NYC — but it might make more sense to donate t=em to an island charity for the write off.

T=e boxes are around \$50 each.

2. We buy one \$750 pro shipp=ng case and send it back and forth between the properties (send to Brice em=ty, have him return it full, ship him the new machine in its new box and se=d the box to FL, etc.). Still going to the island.

And 3. I basically fly in to each site and do the upgrades there.&nbs=;

I don't trust anyone to do the upgrades for me. =lights leaving have to switch off.
