>Dear Rich,

>I met with Eileen and Rich Joslin this evening together in Eileen's  
>office. The intent of the meeting was to tell me what the job offer was.  
>Rich Joslin said to me in the meeting that the offer was for \$62,500. I  
>said to him in front of Eileen you told me \$65,000 on the phone on  
>Friday. Eileen looked some what annoyed with Rich Joslin after I said
