Greetings all, I don't keep written logs of maintenance on the boat engines. The smart gauge that Yamaha provides alerts us to maintenance intervals.

Every hundred hours we do oil and filter change, we check the zinc anodes and replace if needed. Every two oil changes we do lower zinc oil. All of the boats go to offshore every 500 hours for other maintenance that require them to plug computer to engine and get further diagnostics.




