Etihad Airways has waived the limits of liability applicable under the Warsaw convention (or that convention as amended at The Hague 1955 or protocols nos. 1 and 2 of 1975) with respect to loss of life or bodily injury attributable to an accident. However, under the Warsaw convention (or that convention as amended at the Hague 1955 or protocols nos. 1 and 2 of 1975) the liability for the loss, damage or destruction of checked baggage is limited to 17 SDR per kilogram (about USD 20).
