So we are confirmed for 11am on Thursday! Thanks for accommodating on short notice. Here's a few background details for our meeting:

\* The Project: The project is for the family dynasty that owns the Shinsegae Group in Korea. Shinsegae operates one of the largest department store chains in the world, based in Korea, as well as various businesses such as the Westin Chosun in Seoul.
