Good Afternoon Jennie,

The drawings had to be redone today, hence the delay. The unit of interest 33EF is currently on the market for \$5,100,000, it originally was on for \$7,200,000 listed in February 2009, then in February of 2010 it was dropped to \$5,975,000, and in June of this year to \$5,100,000. It has been taken off the market, as you know. It is currently priced at \$2125 per sq ft.

The last two combined units that sold 44BC and 46BC, sold at \$1903 per square foot and \$1626 per square foot respectively. Today

there are two units on the market, 18BC at \$5,975,000 which is \$2067 per sq ft, and 49EF, which is the most similar to 33EF and that is asking \$7,850,000 which is \$3271 per sq ft.

So as you can ascertain, the fact that 33EF is attainable at this price, is an exceptional deal.
