Summary of today's meeting - Tuesday May 25 2010:

1. Drawing A.002 - Site/Construction Plan - Revise position of the Cinema/Projection Room - Robert has given a sketch - will forward revised drawing on Thursday June 27
2. Drawing A-003 - Living & Pool Facade: Revise the grate of the land - no planter & retaining wall - will forward revised Drawing on Thursday June 27; Note: Small office at the end of the Swimming Pool (by the cliff) is to be called a massage room (?)
3. Drawing A.005 (steam room option 02 dated May 20 2010) - Master Bathroom; Picture window in the steam room is clear glass, not alabaster (so that one can see outside)
4. Drawing A-007 - Library Courtyard; Broomed Sweep Finish & Exposed coral stone cast concrete - Border versus field (A noted hard copy is kept for Shelley's records)
5. Drawing A-008 - Powder Room - Waiting for feedback about the bookcase/magazine shelf on vanity
6. Went to Etcetera Showroom (Stone Supplier) and looked at three more stones for accent walls and floor in the Master Bathroom: Mink Marble, Siberian Marble and Honed Gray Driftwood Marble - As soon as we get an idea on availability, RCI will send more info and photos via email. Actual Stone samples will be sent to 9 East 71st St. for review with Robert in next meeting (June 02?). At the moment Etcetera doesn't carry more sample pieces of those stone, the pieces being sent to 71st St. will be our only samples.
7. Will try to Bring [REDACTED] to another stone supplier: Artistic Tiles, as soon as they let us know that the stone that we are interested in are ready for viewing at the warehouse. Should be hearing from them by the end of next week (or mid week).
