Hi Gary,

I am attaching two invoices: one for Stephen's January and February salary and one for March which includes your salary plus expenses.

Stephen is eligible for a reduction in his COBRA premiums if he is terminated by 03/31/10. He will have to pay only 35% of the total premium in order to remain covered under our health insurance plan. This reduction can last for up to 15 months.
