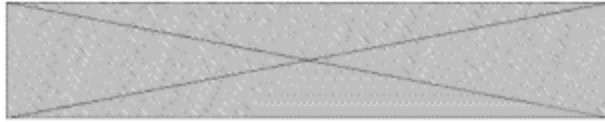

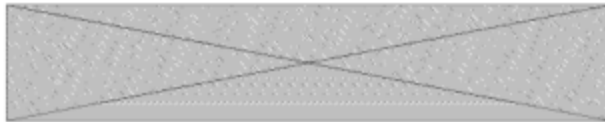
Please find attached the original ceiling rendering you have requested.
