

Gary, it's a pleasure working with you and Mary and getting your rental organized at Cowpet Bay West Condo. To refresh your memory, it's up on our web site, under Vacation Villas, the property name is Villamar.

You want to rent, September 15 – end of March 2010.

Rate is \$3,500/month plus utilities

Rent includes maid service twice/month to be arranged with housekeeper and Mary. Additional maid service can be provided at an additional cost TBD.

We will install a cable box in the master bedroom.
