Below same summary as yesterday but with confirmed speaking engagements included.

Current Liabilities: £ 4,684,436 (completeness not confirmed, no tax status available)  
Might be able to negotiate to defer / convert into 10-year notes (approx. £ 2.5 million)

Business Model:

Use Mothers Army brand (MA) in all activities.  
(MA stands for integrity, consciousness, morals, etc)

Revenues:

Current deals, not signed – DS reviewed contracts:

- Handmade Films for animation of children characters:

- o Executive Producer for series "Tea For Ruby": 15% of producer fee, 7.5% of Handmade fee
- o Series "Tea for Ruby": £125K upon signing against 5% of production budget; 30% adjusted gross of all revenue
- o Series "Little Red": £75K upon signing against 2.5% of production budget; 30% adjusted gross of all revenue
- o Series Nat Geo Kids: £15K per episode; 15% producers fee; 30% of adjusted gross
- o Option to acquire 500,000 shares in Handmade Kids Inc. (to be established) as non-executive Director

Current deals, not signed, DS is still waiting for contract drafts to verify:

- Book "Mothers First" to be published by Atria: US\$500k milestone based plus unknown royalty
- Star Branding (Hilfiger) & Castle Hill (manufacturer): fashion line with Tommy Hilfiger support. Castle Hill guarantees sale of US\$18m over 3 years of which F. royalty is 8% of which 40% goes to Star Branding (*note: bad financial deal but F states that Tommy Hilfiger wants to create TV show staring F and himself about the launch of this label – this would put F. back on screens of US households*)
