Forgive my religious analogy, but the Bible once described a Great Flood that overcame and destroyed this planet. I predict a Great Shallowness overcoming and destroying this planet.

BTW, for your amusement, I spent part of the last month investigating a new cold fusion device for our billionaire engineer pals on the west coast, who were about to sink millions of dollars into this thing. I initially sent the "free" letter of "be carefull, be very careful, etc., but got in response a long letter filled with claims on how this was going to solve the various energy problems, etc. The material was good enough to fool an educated layman, but not an expert.
