As a follow-up. The reason behind the \$1K on the \$1,701,000 is that originally Debra lent Artspace \$450K. When she was repaid by Artspace from the proceeds of the \$1.7mm she was repaid with interest. So the parent Arsp included an additional \$1K in the \$1.7mm advance in order to give Artspace the money to pay the accrued interest to Debra. This does not change the analysis=below.

RA: all \$\$ in as equity originating from phaidon global 1/17/14-10/25/16 in=multiple contributions. Pls note \$125.8k were legal fees paid by PG (having to do with creation of RA and various other matters), ie, \$11,363,381.48 =includes \$125,881.48 of legal fees paid directly by PG to paul weiss.

I'm in a meeting so joe can answer follow-ons and/or make any additions. Still tracking down disclosure questions and also having RJ breakout end of =5 tax basis. Will have to project end of 16 basis for both AS and RA.
