The initial install entailed laying 6-8 ft of conduit from Centurylink Demark to an Existing Conduit owned by tower owner= Sierra Nevada Towers.

The Tower owner has indicated the existing conduit has been badly damaged and there will be a need to lay a new run of conduit from Dmark to this building. (40' rigid buried and 140' above ground galvanized conduit.), Sierra Nevada have indicated a Estimated Cost of \$4500.00, with
