Per our discussion ea=lier this week we follow up with Dragonwave on an exact date of delivery. =dragonwave has informed us that the radios (Long lead item) would ship by no later than 7/29.

Net of this, we would like to plan for the followin= to help mitigate the timing delay of the radio arrival and try to keep th= installation timing as tight as possible and stick to the original solution using the E=hanced Multi-Carrier solution.

Seq=ence of Events:

- * Pre-ship all materials besides the radios (T= arrive in market the week of 7/25 or earlier)
 - * Antennas, Mounts, Installation Materials, Ca=le, etc.
- * FT build crew to arrive in market on Su=day 7/31/16
- * =span style="font-size:11.0pt;font-family:"Calibri",sans-serif"=FT will begin the construction on 8/1/16 starting with the Main Residence =ocation
 - * Onc= the main residence location is complete, we will move to Sandia Crest<=u>
 - * By the time FT is CONSTRUCTION COMPLETE on b=th ends the radios will arrive in market.
 - * FT will th=n pre-configure the radios at the main residence location and then install=them on each end
- * Once the radios are installed, FT will =egin the link alignment. (We would expect to be at this point by Friday 8/5/16
 - * In the case the Sandia Crest to Main Residen=e location does not meet the performance requirements, we will then go build the ZDC tower and relay the connection through there=u>

Please review and let us know if we can move forward on =his basis.
