The checking account current balance is \$4,729.18 and we are due a credit of \$67.85 from the City of West Palm Beach for water/sewer. It will be mailed to me and I will deposit it in the account. I think all other bills have been paid.

Please see attached the accounting of my deposits into the 124 Parc Monceau, LLC account.=C2♦ I included the \$40,000.00 I loaned to Paul. When you examine the bank records you will see I made all deposits except for a few in 2013. I think the \$9,000.00 deposit made on 12-11-2013 is also mine and I am trying to determine from what personal account I made the deposit. Interestingly, Charlie Barnett found photocopies of the check register among Paul's papers. No actual checkbooks or registers have surfaced.
