We have some good news. The Aspen Institute often organizes Congressional staff delegations and we just got a call from a Congressional office letting us know that they will be participating in a trip to Senegal next weekend. This could be a substantial opportunity to meet with some very influential foreign policy Congressional staff. We have spoken to Yebbie Watkins, he is one of the most influential staffers in Congress as he is the Chief of Staff for the House of Representatives Whip Congressman James Clyburn. We have briefed Yebbie on Mr. Wade's situation and he said that he would be willing to meet with Mr. Tidiane or another representative of Mr. Wade that you recommend. This could be a great opportunity to get Mr. Wade's story told to some very important Congressional leaders. Furthermore Yebbie is a leadership in the Congressional Black Caucus, as you may recall they are a group that we identified in an earlier correspondence as both highly influential and one that could potentially help us get even more attention around Mr. Wade's incarceration.
