attached progress photos of the EGP. </=iv> The leveled area to the north was needed for Sky Track and Skid Steer access to build the extension to the Rock Retaining I expect to have Rock Wall finished by Friday, then we start backfilling and compacting the new NE corner of East Garden Bed.

Rough grade material will be 1' below grade, then we will add 1.5' of good topsoil to make finish grade. </=iv> I hope to be at rough grade by the 2nd week of January 2016.

We need to compact the dirt and rebuild the retaining wall at the NE corner, before doing final rough grading at the east end of the existing garden</=iv>
