Europe airspace is requiring us to have TCAS 7.1 software installed by Jan 1st, 2016 for the B727.

U.S. Airspace is not required to have TCAS 7.1 until year 2020.

Cost for software upgrade to 7.1 TCAS = \$60,511 (due to age and Mod status of B727 TCAS unit, we have to upgrade our box before 7.1 software could be installed).

We have 7.1 TCAS already installed in GIV, when we upgraded to U885.

I will have another price quote on Monday from Banyan Avionics Fort Lauderdale.
