Well, this came in today, and this clarifies some things.= Particulary it is clear that this office is not really following any procedure and isn't out to deal with me in a way that respects my=rights. (no surprise to you!). Statements like "include, but=not limited to"? What the fuck is that? Also, it seems=clear that from the list of 'allegations' (and note they d=n't explain which ones they are actually investigating), that the =ist is basically the buzzfeed article.. so indeed they are not restricting=themselves in at least listing just university related ones (items 4 and 5=. and re 5, what the fuck? Who the fuck cares what an employee think= about a donor?)

Anyway, it is clear to nancy and I that we need to bring Justin in, at least as an advisor before I have my=meeting next tues.. I was going to consider bringing him in depending upon=what I heard there, but based on this, there are various jurisdictional is=ues, and respecting my rights issues that I need to be guided on. =C2♦(I plan to ask specific questions now during the meetings next tues, =ut not give responses at the time).

So, at=this point I plan to write to her to ask her for some specifics (which I d=n't expect her to agree to answer till we meet, but we will see), =nd contact Justin to let him know I will pay his retainer. I don♦=80♦t want him accompanying me to the meeting on Tues, but I want to plug=him in the loop with me, and help me know what to ask, and how to be prepa=ed to respond....
