J. Dismissal or Suspension

1. Tenur=d Faculty Members

1. Tenured faculty members shall not be dismissed or suspended without pay=except for just cause. Such dismissal or suspension may take effect only f=llowing an opportunity for the faculty member to utilize the conciliation/=ediation and hearing procedures as prescribed in ABOR Policy 6-201L.3 and =.4 (Conditions of Faculty Service; Hearing Procedures for Faculty, Concili=tion/Mediation and Hearing).

2. Just cause shall inclu=e, but not be limited to, demonstrated incompetence or dishonesty in profe=sional activities related to teaching, research, publication, other creati=e endeavors, or service to the university community; unsatisfactory perfor=ance over a specified period of time and a failure to improve that perform=nce to a satisfactory level after being provided a reasonable opportunity =o do so by the university, as demonstrated through the board-approved post=tenure review process; substantial neglect of or refusal to carry out prop=rly assigned duties; personal conduct that substantially impairs the indiv=dual's fulfillment of properly assigned duties and responsibilities; m=rал turpitude; misrepresentation in securing an appointment, promotion, or=tenure at the university; or proven violation of Board or university rules=and regulations (including the code of conduct or any other disciplinary r=les), depending upon the gravity of the offense, its repetition, or its ne=ative consequences upon others.
