Jeffrey, please see below. Clare called me and indicated that, based on your strong recommendation, Mort wants someone to review Ellen's documents. For reasons noted below, I don't think it is appropriate for us to play that card.

My earlier review of prior counsel's work occurred before Ellen was on the scene. I was told that I would handle Mort's estate planning. During my preliminary review, I identified a huge issue and developed a strategy to fix the problem. Nevertheless, Mort decided to use Ellen, both to fix the problem I identified and to provide additional estate planning services.

Subsequently, I was told that he wanted to use me. But again it became apparent that he wanted to continue with Ellen. At that point, I did not review the documents, nor did I do a deep dive in the structure. Rather, my conclusions were quite general.

Given the circumstances, including the issues you raised on the phone, I don't think Paul, Weiss should undertake a full review of someone else's work.

Would you like me to recommend lawyers who might be willing to review someone else's work? Or will you tell Mort you don't recommend a review by another law firm?
