Jeffrey.. Thanks very much for your advice.. We are not yet =n the labor law phase.... nowhere near that yet.. In any =ase, just FYI.. I am sending you the section of the ABOR regulations on =ismissal or Suspension of Tenured faculty, so you will see it is a long =rocess that extends way beyond what I am embarking on next week. =nbsp;

In any case, as a =result, I am taking the following action today. I want to continue =isten carefully to your advice, believe it or not, but I need to feel I =ave a legal expert familiar with Title IX to talk with as well, and =here is no perfect person.. but Nancy and I have decided to =etain Justin, who, while perhaps too eager to be combative at this =tage, will work for me, and not vice versa, and has extensive =xperience with university processes, including at ASU. His main =nterest is making the process fair, and if it is not, holding the =niversity accountable after the fact. I think that meshes with my =oal as well. I do feel much better about him than I did about having =ohnny's lawyer, which was delusional on my part. Plus I will be =uch more critical of advice, as I will be bouncing it off you as well.. =nbsp; I hate spending the money, but Nancy reminds me that in the old =ays this is less than I would have received for a single lecture. =nbsp;

So, =nce again, I understand your concerns.frustrations, knowledge, =ecriminations, etc, but this is what I am going to do. So, I am =ither going to waste \$15K or get some useful payback for it, and I will =ither kindly accept your offer to let me waste your \$25K, or my =25K. If you feel sufficiently strongly that you don't =ant to follow through on what you so generously offered before, which =as to provide \$25K for me to work with however I felt I wanted to do, =nd perhaps largely for our mental health if necessary, I will not =nbsp;of course hold it against you in any way. You have been so =enerous with your time and friendship, which in the end is so much more =important.

ABOR stuff below:

J. Dismissal or Suspension
1. Tenured Faculty Members

1. Tenured faculty members shall not =e dismissed or suspended without pay except for just cause. Such =ismissal or suspension may take effect only following an opportunity =or the faculty member to utilize the conciliation/mediation and hearing =rocedures as prescribed in ABOR Policy 6-201L.3 and L.4 (Conditions of =faculty Service; Hearing Procedures for Faculty, Conciliation/Mediation =nd Hearing).

2. Just cause shall include, but not be limited to, demonstrated =ncapacity or dishonesty in professional activities related to =eaching, research, publication, other creative endeavors, or service to =he university community; unsatisfactory performance over a specified =eriod of time and a failure to improve that performance to a =atisfactory level after being provided a reasonable opportunity to do =o by the university, as demonstrated through the board-approved =ost-tenure review process; substantial neglect of or refusal to carry =ut properly assigned duties; personal conduct that substantially =mpairs the individual's fulfillment of properly assigned duties and =esponsibilities; moral turpitude; misrepresentation in securing an =ppointment, promotion, or tenure at the university; or proven violation =f Board or university rules and regulations (including the

code of conduct or any other disciplinary rules), depending upon the gravity of the offense, its repetition, or its negative consequences upon others.
