I want to continue listen carefully to your advice, believe =t or not, but I need to feel I have a legal expert familiar with Title =X to talk with as well, and there is no perfect person.. but =ancy and I have decided to retain Justin, who, while perhaps too eager =o be combative at this stage, will work for me, and not vice versa, and =as extensive experience with university processes, including at =SU. His main interest is making the process fair, and if it is =ot, holding the University accountable after the fact. I think =hat meshes with my goal as well. I do feel much better about him than I =id about having Johnny's lawyer, which was delusional on my =art. Plus I will be much more critical of advice, as I will be bouncing =t off you as well.. I hate spending the money, but Nancy reminds =e that in the old days this is less than I would have received for a =ingle lecture.

So, once again, I understand your concerns.frustrations, =nowledge, recriminations, etc, but this is what I am going to do. =o, I am either going to waste \$15K or get some useful payback for it, =nd I will either kindly accept your offer to let me waste your \$25K, or =y \$25K. If you feel sufficiently strongly that you don't =ant to follow through on what you so generously offered before, which =as to provide \$25K for me to work with however I felt I wanted to do, =nd perhaps largely for our mental health if necessary, I will not =nbsp;of course hold it against you in any way. You have been so =enerous with your time and friendship, which in the end is so much more =important.

J. Dismissal =r Suspension
1. Tenured Faculty Members

1. Tenured faculty members shall not =e dismissed or suspended without pay except for just cause. Such =ismissal or suspension may take effect only following an opportunity =or the faculty member to utilize the conciliation/mediation and hearing =rocedures as prescribed in ABOR Policy 6-201L.3 and L.4 (Conditions of =aculty Service; Hearing Procedures for Faculty, Conciliation/Mediation =nd Hearing).

2. Just cause shall include, but not be limited to, demonstrated =ncompetence or dishonesty in professional activities related to =eaching, research, publication, other creative endeavors, or service to =he university community; unsatisfactory performance over a specified =eriod of time and a failure to improve that performance to a =atisfactory level after being provided a reasonable opportunity to do =o by the university, as demonstrated through the board-approved =ost-tenure review process; substantial neglect of or refusal to carry =ut properly assigned duties; personal conduct that substantially =mpairs the individual's fulfillment of properly assigned duties and =esponsibilities; moral turpitude; misrepresentation in securing an =ppointment, promotion, or tenure at the university; or proven violation =f Board or university rules and regulations (including the code of =onduct or any other disciplinary rules), depending upon the gravity of =he offense, its repetition, or its negative consequences upon =thers.
