1. The new Apple TV will be available in late October. N= announced date for preorders, yet.

Important to note on the Apple-TV is that there is no longer a separate audio output — everything=goes through the HDMI cable. If the projector or tv that it's plug=ed into doesn't support audio-over-HDMI, it won't work.♦=A0

I'm not sure if any of the current set=ps rely on the optical audio cable going to a separate receiver currently,=but they will need to be reconfigured to work with the new model.

2. The iPad Pros will be available=in November. No date announced for preorders, yet.
