i just spoke with Leighton and communicated that your compensation terms would be as follows:

- 1) 175,000 per annum (paid monthly as an independent contractor)
- 2) housing at 301 apt #8 valued at 3500 x 12 = 42,000
- 3) health insurance - we will pay his Cobra (Leighton must verify but he believes it is approx 2200 per month) = 2,200 x 12 = 26,400

Total annual cost = \$43,400

Other One Time Costs

leighton also kindly requests that you cover his relocation cost which will be 6,500

please note we will have to pay a 20% fee (reduced from 25%) to Russell which i will negotiate that we pay monthly in case Leighton does not work out i will also negotiate with Russell that fee will be capped at 25,000 vs 35,000
