The process =C2♦goes this way.... first we have to meet our standard production=of Black bumpers for our distr: and our dealers.. once that is done we now=can take time to set up the injection machine, for white.... We hav= to order out the color from our resin foam company, that takes a week to =et sometimes longer, It takes about half day to change over black to white=. We waste about 3//4 of a

drum of resin used to flush, that cost is=passed on to you, labor and material used. A 400.00 charge per custom colo=... The resin has to be blended with U/V additives for yellowing ♦=A0we spray in a TOP U/V paint that bonds to the urethane resin once inject=d into the mold....This is a pain staking process. With all that inv=ked we normally tell our customers 4 to 6 weeks.
