We are in receipt of the offer received by you from Michael J Sala on behalf of Larry Flint. This was received on Friday evening=after working hours. We are therefore seeking an extension to reply. Also we need sometime to consider Mike's offer.

I have gone through the offer and suggest the following amendments :-

1. ♦=A0 The offer should be in the name of Essar Shipping Ltd (ESL) , Essar House, 11 KK Marg, Mahalaxmi, Mumbai – 400 =34. They are the present owners of this aircraft.

2. ♦=A0 Refer para 2 --- the aircraft is current on its respective maintenance schedules , with all mandatory SB's and =D's accomplished as on date; shall be delivered on 'as –is – where-is bas=s".

3. ♦=A0 Visual and Technical acceptance -- ♦=A0please specify where required.

4. ♦=A0 Refer para 2 -- As regards Export C of=A from India please be advised that :

a) =C2♦ The Indian DGCA issues Export C of A for one destination flight only , in this case aircraft will be positioned at Inspection facility and upon acceptance may have to fly to another destination.

b) =C2♦ This aircraft was earlier registered in US (=40SR) and can be easily registered in the US. </=>

5.♦=A0 Para 5 – This offer will be accepted=once the Buyer has requisite funding in place.

6.♦=A0 Refer para 7 --- The aircraft may be rejecte= only if :-

♦=A0 Damage history or Material Corrosion is found by the =nspection Facility and/or,

♦=A0

(=i) ♦=A0 Discrepancies beyond repair, as determined by the Ins=ection Facility, which make the Aircraft unable to be delivered in the Delivery Condition a=d/or,

This is similar to the LOI with Corsons Trade Ltd.

7.♦=A0 Refer para 8 – Closing shall occur w=thin 7 days of technical acceptance of the aircraft after PPI.</=>

8.♦=A0 Refer para 11 – the closing date can=be confirmed once para 5 (financing) is in place.=/p>

9.♦=A0 The aircraft is presently in EBACE and we wi=l respond no later than Friday May 22nd.

We trust you will find the above amendments are=in order & look forward to receiving the revised LOI asap.</=>
