Between 1993 and 1994 he served as the chef de cabinet of Slovakia's then Foreign Minister and later Prime Minister, Jozef Moravčík <https://en.wikipedia.org/wiki/Jozef_Morav%C4%8D%C3%ADk> . Between 2001 and 2005, Lajčák was based in Belgrade <<https://en.wikipedia.org/wiki/Belgrade>> as Slovakia's Ambassador to the Federal Republic of Yugoslavia <https://en.wikipedia.org/wiki/Federal_Republic_of_Yugoslavia> (he was the EU's supervisor to the 2006 Montenegrin independence referendum <https://en.wikipedia.org/wiki/Montenegrin_independence_referendum,_2006> .
