· =C2 September 5th, he received the request for evi=ence

- =C2 September 9th, he emailed me a list of things =hat we could send as evidence
- =C2 October 9th, he emailed me: "All the materials you provided for Jean Luc have been provided to immigration and we are awaitin= their reply. As soon as I have additional information I will immediately =et you know. We should have information shortly. In the meantime, if Jean =uc is abroad and must travel to the states, he can enter under the ESTA visa (formerly VWPP) program which=is available to all nationals of the European Union. After the O-1 visa pe=ition is approved, Jean Luc will be able to have the visa issued at the U.=. Embassy in Paris. I will send you the online link for the ESTA program in the event Jean Luc is not regi=tered on the site. I promise I'll be in touch as soon as I have good n=ws".
- =C2 October 15th, he text me: "No news, but p=ease know we are on top of it and it is one of our very top priorities!!&q=ot;
- =C2 October 22nd, he text me: "We really shou=d be receiving notification from the Vermont serv center very shortly. =A0 I will check again with them today. Remember Jean Luc can always enter the US under ESTA program while the O-1=petition is pending at immigration. I'll update you later today.=u>
- =C2 October 28th, he text me: "Believe me I a= very frustrated, especially since they have approved our petitions 3 prev=ous occasions! Today, I'm contacting my friend who is the District Director for a member of Congress so that sh= can help on this. It really shouldn't be much longer. =I'll let you know immediately upon having any additional information.=C2 Hopefully this week".
