I'm guessing that the bos= means the new iPad Air 2 (the mini update was minor). The 128GB cellular model is \$829+ \$99 for AppleCare+. 4-6 days til shipping.

For the MacBook, we have choices between the 1=" MacBook Air, the 13" MacBook Air / 13" Retina MacBook Pro=or 15" MacBook Pro, depending on who needs it / for what they're =sing it.

As a baseline, the 13" MacBoo= Air with Core i7 CPU, 8GB RAM (the max) and 512GB storage is \$1,749.00 + =250 for AppleCare. 1-3 day to ship.

The log=stics of the iMac upgrades are a challenge. We have three choices:

1. Buy cardboard shipping boxes for Zorro, Paris, + Flori=a and have them ship the machines to NY for me to migrate the data. <=div>

And 3. I basical=y fly in to each site and do the upgrades there.
