"Arizona State University has protected faculty sexual predators for decades," said Jasmine Lester, an ASU alum and director of the organization, told Gizmodo via email, referencing past incidents when ASU professors <<http://www.phoenixnewtimes.com/news/barrett-the-honors-college-at-asu-is-a-close-knit-community-some-say-too-close-6633269>> have been found to be sleeping with their students, "but we hope that with so many witnesses and victims speaking out the ASU administration will make the decision multiple peer institutions have made to ban Krauss from campus and protect students from sexual violence."
