Davis responded that the Merchant case was “unchar=ed territory” for the NSF and highlighted gaps in communication between different branches of the NSF—gaps the agency is now trying to plug. She stated that =every sexual harassment case reported to the NSF now will be coordinated with her office. She also affirmed the NSF’s goal to be more proactive =n documenting cases, disclosing that the agency was made aware of an university placing a faculty member on administrative leave pending an investigation just this past Thursday. Within two hours, Davis said, her office had assembled a team to look into the matter and updated its database with information about the case.
