I have excluded Landing Gear and included my own approach for external inspection=20 "Gulfstream factory preflight" this should lead Dennis to believe=we are not accomplishing the Gulfstream Full airframe Survey, however I will have Gulfstream complete a full walk around of exterior and rear equipment bay=20 which requires a maintenance person to visually inspect the entire exterior fuselage for any discrepancies or un-airworthy items,.I also included a visual inspection for under fwd and aft lavatories, checking for corrosion =nd compliance with ASC469 (water Line inspection).

I would like to get Sean Lancaster's opinion and Sean Brown (Gulfstream Maintenance lead) on this inspection to verify I have not overlooked an=20 area, and we have inspected area's so I'm able to maximize our repair prebuy.

May I fwd this to Sean L and Sean B for their opinion?

*** I'm not sure how much time Sean Lancaster will devote to giving us a real answer since we still owe Bristol for S76 sales invoice (approx \$11,900) Sean is leery of getting to involved in helping us.
