the other bleed is from an adhesion in my belly/pelvis from one of the=surgeries. it started as a pseudo-obstruction and since the tissue is fria=le and not as good as some of my other (stellar) tissues, it bled. this on= seems to have stopped on its own. it bled but eventually stopped because =t was in my pelvis and my guts were able to tamponnade the bleeding.

the confusion is really around why two bleeds at once. my platelets se=m to be ok (in number) but the way we first found this weird cancer is tha= i had these weird antibodies to platelets that were being secreted by the=ovarian tumor. also thyroid antibodies. so perhaps we are seeing early tum=er, secreting antibodies to platelets and making me bleed. or perhaps, i ^;ve just some post-op complications.
