Jeffrey:

For your Organic Garden I have had several conversations with Jasper Templeton & Nora Chapman i= St. Thomas who are active in the organic gardening business. I believe we could develop a very productive & attractive garden in the existing terraced nursery area.=A0 I think the best solution would be to:

1. Remove the existing metal nursery table stands and then enclose those areas with 18" – 24" stone walls so that we could create adequate soil garden plots with drainage holes.
2. Backfill the planters with a layer of crushed stone for drainage, a filter fabric and then backfill with a good organic plant mix. They reco=mend a mix consisting of Promix Soil & Happy Frog Organic Soil. This mix is very rich and totally organic.
3. Install a drip irrigation system which saves water and is concentrated on each plant.
4. Jasper & Nora would write a maintenance schedule for us and would be available to come out to give instructions to our maintenance staf=.
5. We would have to designate one of our maintenance people to take charge and be responsible for the maintenance or we could hire someone=for that purpose. It should be someone who is passionate and focused.
6. Let me know what you think and exactly what type of vegetables you are interested in.
