Dear Rich:

Bainco has authorized me to confirm that it will meet your demand with =espect to Noam's investments in private equity partnerships at =ainco. Our understanding is that Noam invested a total of =267,500 (through his revocable trust and his IRA) and received a tax benefit of approximately \$27,000 due to realized capital losses, =esulting in a net investment of \$240,500. Bainco will pay that =mount to Noam and Noam will relinquish his entire interest in the =private equity partnerships (a portion of the settlement amount may be paid through a third party's purchase of Noam =99s interest in the RFID partnerships at his original purchase =rice).
