Bainco has authorized me to confirm that it will meet your demand with respect to Noam's investments in private equity partnerships at Bainco.=C2 Our understanding is that Noam invested a total of \$267,500 (through his revocable trust and his IRA) and received a tax benefit of approximately \$27,000 due to realized capital losses, resulting in a net investment of \$240,500.
